### VII. ITEMS FOR DISCUSSION

- A. The Economic Development Corporation Board to discuss economic development and marketing activity, prospect updates
  - The opening of the new 7/Eleven was on December 20<sup>th</sup> and area businesses have seen business improve since that opening.
  - Executive Director reported that she had the Lavon booth at the ICSC International Council of Shopping Center Red River Conference and Trade Show January 7-9<sup>th</sup> at the Fort Worth Convention Center.
  - Many retailers are interested in the growth in Lavon and Brookshire Grocery stopped at the booth to obtain information about Lavon.

# B. The Economic Development Corporation Board to discuss the Small Business for Spring

- April 13<sup>th</sup> was selected as the preferred date after discussing all dates in April and May.
- Directors recommended using post cards and only mailing to the public 2 times.
- The Fall, Christmas Bazaar on Nov 16<sup>th</sup> was the preferred date.

## C. The Economic Development Corporation Board to discuss board financials

The revenues continue to increase each month. The budgeted amount of incentive funds increases every year. The payment for last year's audit occulted in this fiscal year and results in a line item exceeding the budgeted amount. A budget amendment will be necessary at mid year to consider this item.
